'CAN I TALK TO YOU?'

GET INVOLVED!

I had worked hard that day at a new temporary job while a friend was on vacation. I was tired from the change of pace. My wife suggested that I lie down and rest while the steaks cooked on the outdoor grill. As I started to pull the curtains in the bedroom to close out the late afternoon sun, I noticed a pickup truck stop at the front door. A man, not too well-dressed, got out and walked slowly and cautiously to the front door. Not wanting to have any supper delayed, I went to the door. "Hello. What can we do for you?" "Can I talk to you for a few minutes?" "Sure. What's on your mind?" "You're Frank, right? And you're an alcoholic, right?" His questions made me angry. He was very nervous, glancing around and down at the porch floor, his cap pulled down over his eyes. In fact, I was very angry. "Yes, I'm an alcoholic." I did not know this man, and it was none of his business what I might or not might be. My anger hit the boiling point. "Who are you? What do you want? Who told you I'm an alcoholic?" I raged on. "What right do you have to come to my home and start making remarks of any kind about me?" He removed his cap as he began to speak, and this time. I could see a troubled man, with bloodshot eves and tears running down his cheeks. "I'm in trouble. I need your help. About eight months ago, I saw you at an AA meeting. You were so honest and sincere when you told about being an alcoholic, and asking for help, about going in the hospital for twenty-eight days. Can you tell me, am I an alcoholic? Can you make me stop drinking? Can you cure me?" My anger left. Compassion and humility filled the void. "No, my friend, I said, thinking of the answers I had been given when I asked for help. "Only you can say if you're an alcoholic. No, I can't make you stop drinking. Only you can stop when you're ready to stop. There is no cure for our disease, but God can help! And AA can help." I had not remembered him. That had been his first meeting and only meeting, eight months ago—for me, eight slowly recovering, gratefully recovering months. We sat down and talked for a long while and exchanged a lot of questions and answers, Then we took the fist three Steps of AA together. Did he understand? Was he ready to give up drinking and his alcoholic ways and turn his will and his life over to God or a higher power of his understanding? "Yes!" I explained the sponsor system to him and agreed to be one of his sponsors and handed him a token that had been given to me, bearing the words "Think! Call your sponsor before, not after, you drink!" "You do me an honor," I said, "by coming to me. Keep the token as long as you don't drink. Sometime, you may want to pass it on to somebody else after you begin to collect other chips—the white one for surrender, red for three months, green and yellow, and so on. Remember, you're only human. If you drink again, throw the token away, but you come back. It's you, your life, your family that I'm interested in for the future." He promised he would be in touch and would be waiting to go with me to the next AA meeting. He would call when he got home. The call came ten minutes later: "Thank you." His son and grandson had been there when he got home. My family had eaten an hour earlier. All at once, I was no longer tired. I sat down to a supper that had been kept warm—steak never tasted so good! F. E., Boone, N.C.

One of my favorite gals in AA told me her definition of sobriety is that it's a gift. A gift we keep by giving it away. I love this interpretation and have adopted it as part of my own thinking. This flow of receiving and giving can be reached only by involvement. What is involvement? It's saying "Yes" when called upon to serve. It's cleaning ashtrays, making coffee, speaking and chairing at meetings, going on Twelfth Step calls, working with institution groups—you name it. It's carrying the message the best way we know. Our intergroup (called the central office in some area) has eighteen groups, and it has only five institutions to cover. Yet when institution-assignment time rolls around (almost always the final item on the agenda, for some reasons shortly to become apparent), the chairman sheepishly says, "Well it's that time again. Now, what group would like to volunteer for the men's prison?" Silence. "Women's prison?" Silence. Finally, after several embarrassing moments (while, ideally, each representative at the intergroup meeting examines his group conscience), a few volunteers squeak through. And it's usually the same few groups whose representatives volunteer to provide speakers. One common excuse is: "I can't accept that institution for my group. We have our regular meeting that night." Comment: So what if you or some other member misses the home -group meeting one night? What's to lose? It's a winners game, with you on the winning side. We always get back much more than we give by going to these people who can't come to us. Another alibi is: "People in institutions aren't interested; they don't listen." Comment: How do we know? Last night, tonight, or tomorrow night, a guy or a gal may start a whole new way of life because of something said to an institution group by an "outside" AA member. And then we hear: Institutions aren't my cup of tea. They upset me." Comment: This is true in some instances. But before you make an arbitrary judgment, try actually going to a prison, state hospital, etc. So many people who make this statement have never been to "one of those places." Don't knock it until you've tried it. I can't help feeling that the groups' institutions or intergroup representatives are reluctant to volunteer because of these or other excuses they hear from group members. So many of us said, "Oh God, I'd do anything to stop drinking, anything!" And then we were introduced to AA and this wonderful program. The physical pain began to disappear; the mental agony dissolved; our spiritual beings were uplifted. The compulsion to drink was removed. The gift of sobriety was bestowed upon us, and we learned, by using the keys or tools of the AA program, that the longer we were sober, the better life was. But one day we seem to hit an impasse. We think, "I'm sober. Life is good. But something is missing." Twelfth Step work, maybe? Institutions coverage is one kind of Twelfth Step work. Talk your group's institutions or intergroup representative. Ask him to volunteer to cover an institution, so you can go along to speak there. It can't hurt—it may even help.

Chair Report: Jessica attended area assembly in Sarasota. Treatment committee suggested having a bridging the gap coordinator. For the next area assembly Jessica will bring the literature that we are using for bridging the gap. Allan D is our new treatment committee chair. The report was then accepted without any changes. Secretary Report: Gaby then read the secretary report for the month of December, and it was accepted without any changes. Treasurer Report: John T then presented the treasurer's report. The current pink can balance is \$2808.41. Our committee received \$981.31 from the following groups: Keep it Simple Pass it On, Language of the Heart (3333), Living in the Solution, Ruskin Fellowship (Sunday), Staying Alive, Tampa Saturday Night Speaker Meeting, and Women's Friendship. Monthly expenses included \$50 for the central office storage, \$250 for the annual website maintenance fee, and \$555.26 for the renewal of ring central. Literature expenses this month was \$242.57. Report accepted without any changes. Treatment Centers: John T reported on the following treatment centers: ACTS amethyst/detox is all good and covered. ACTS Juvenile is going well. Cove housing is going well, low resident attendance, but attendance overall good. Sandra Prince is going well. Cove behavioral is going well. North Tampa behavioral now has 2 meetings a week and is going well Operation New Hope may switch their meeting day to Wednesdays and is also going well. Clean Recovery is going well. Turning Point is going well. TrueCore is wanting to take in meetings into their Juvenile facility for boys in Brandon per Jenna M. They are also looking into taking meetings into their women's juvenile facility in West Tampa. Jenna is looking for a liaison to replace her. Corrections: Pasco Women's Jail is now being covered every Tuesday per Jessica M. However, volunteers still needed. Falkenburg Men's Jail is going well per Rich. They are going in 3 meetings a week, but volunteers are still needed Literature is going in successfully. Falkenburg Women's Jail is having 2 meetings a week per Bianca H. They are on Friday at 8 p.m. and Sunday at 3 p.m. Residence attendance averages at 15 a meeting. They also have 14 active volunteers. Meetings are also on Wednesdays, needs volunteers. Zephyrhills going well, Tom F reported. Great residence attendance. Bridging The Gap: John T reported that were 7 bridges out of 9 calls 7/9. There is an open position for Bridging the Gap Coordinator and Alternate Coordinator. Man on the Bed: Mindy W reported that there were 7 calls. 5 people were visited and 2 were attempted. Social workers have reached out to her have a better understanding of Man on the Bed. Mindy is looking to expand Man on the Bed to additional hospitals. Mindy is also looking into getting references from Tampa General Hospital for future opportunities at other hospitals. There is an open position for Man on the Bed Alternate Coordinator. **Old Business:** Jorge was contacted from River Oaks about possibly discontinuing meetings. Jorge advised we continue to hang in there. New Business: Jessica brought up possibly implementing the New Language Big Books into the jails. Motion was made to purchase a case to keep in the locker and use as needed. We voted in favor of. John T stated that there is a new behavioral health facility where we could possibly bring in meetings. It is operated by Tampa General Hospital and will open in March of 2025. Jessica M brought up that we should have a coordinator for Bridging the Gap. There is an open position for Bridging the Gap Coordinator and Bridging the Gap Alternate Coordinator. There is also an open position for Man on the Bed Alternate Coordinator. Meeting ended at 11:21 a.m. with the Responsibility Statement.

(Because of time restraints the Board & Council meeting has been combined.) Board Members present: Al B., Linda B., Dody H., Debbie S., Sophie C., Scott B. & Brian L. Board Meeting: Al opened the meeting by announcing that they would do the Serenity Prayer at the regular Meeting and then announced "Sophie, you're up." Sophie replied that she wasn't sure why he said that she was up but she had a couple of questions about Tim wanting to change his hours. It was her understanding that usually the Board hears the conversation first before we bring it to the Council. We don't have to have the Council vote on that. It's all Board. Tim was asked to explain about the Office Hour changes. Tim explained that the Tuesday and Thursday the hours are from 11:00am to 7:00pm and that at night being the only business open in the building and with our location in the back and fenced off, it is kind of spooky being all alone. The new Office Hours would be: Monday, Wednesday and Friday would remain the same...9:00am to 5:00pm, Tuesday and Thursday would be 11:00am to 5:00pm and Saturday would be 9:00am to 5:00pm. Brad made a motion to change the hours as Tim had described. It was seconded and approve by the Board members. Al then apologized for not being at the previous Board meeting. His wife was in the hospital. Then he brought up the Christmas Bonuses for the staff. After some discussion, bonus were approved. Discussion moved to the Office Managers insurance. Some discussion followed and a motion was made to continue paying the insurance. Motion was approved. The next line of business was the Office managers evaluation. Tim will send out an evaluation form to three members. This was followed by the increasing of wages for the contact laborers. Discussion followed about bringing up their wages to minimum wage. More discussion followed and it was finally agreed to bring their wages up to \$ 15.00. Sophie had made a motion to bring up the wages to \$14.00 an hour, this motion was amended to bring the wages up to \$15.00 an hour . The motion was seconded and approved. Sophie made a point of order: These discussions we are we are having here, they really for the Board, you can put Board minutes together and everyone gets them but I don't think the rest of the Council members need that information, in my opinion, that's just my opinion, we have the funding, and that just makes sense, it's just a lot of information. I do think they need to know the revised hours because Saturday more people are available Saturday for foot traffic. Brad noted that there was one minute left. Al noted that they could pay Tim \$50.00 bucks and make him work on Sundays. Some got a good laugh Al noted that he needed to think about that cause you got to remember the Council oversees the Board. That's the By Laws. Sophie stated that maybe a new item at the next Board meeting would be a review of the By Laws. That may take a few meetings. At that time Debbie spoke up noting that she could not read the minutes at this time, there is a bad accident in front of her and could someone cover her. Council Meeting: Al opened the meeting with a moment of silence followed by the Serenity Prayer.

Because there was so much discussion at the meeting...I may not have the space to include everything.. Secretary **Report**: Linda read the December Minutes. Nes made a motion to approve as read, this was seconded & approved. Treasurers **Report:** Sophie presented the November Treasurer's Report. Contributions in December totaled \$4,075.35. This accounts for what 25 Groups or Individuals in our area have contributed in December, also included is, \$727.72 from 12 Groups or Individuals who made contributions through PayPal. We also received a \$19.00 contribution for 1 member of the Birthday Club. Sophie noted that our literature sales were down considerably, so she encouraged everyone to purchase from Central Office rather from other sources. Our literature sales for December was \$5,413.11, along with \$21.00 for 3 newsletter subscriptions. This includes sales from A.A. material and non-A,A, material (medallions—etc.). Our total income for December was \$9,509.46. Our Total Cost of Goods Sold was \$4,541.46. Subtracting the Total Cost of Goods Sold from our December income left us with a Gross Profit of \$4,968.00. Total Expenses for December were \$9,911.07. Subtracting our Expenses from our Gross Profit gave us a Net Income of minus-\$4,943.07 for the month of December. She then presented the Closing Balance for November. Sophie went on to say that they had done a survey with other district treasurer's and they have about a six month prudent reserve. Nes asked about the literature sales being down, could you compare that to last years at this time? Sophie quoted last months sales compare to December. Then Sophie went on about the Plain Language Big Book sales run from New York. Nes went on asking about a suggestion on what to sale it for vs the price for the hard cover Big Book. More discussion followed. Tim was asked how the pricing works. Yes we have to charge a dollar or two more or we wouldn't make any profit. More talk about the Plain Language Big Book continued. Dody had a question about picking up literature for another group. Go to page 5.....


© Today in January, 2025 we currently have 191 Groups in the Hillsborough-East Pasco area with around 498 meetings weekly. Also we have 128 Zoom meetings weekly. Contributions in January totaled \$10,793.94. This accounts for what 46 Groups or Individuals in our area have contributed in January, also included is, \$1,414.03 from 10 Groups or Individuals who made contributions through PayPal. We also received a \$36.00 contribution for 1 member of the Birthday Club. Our literature sales for January was \$3,325.75, along with \$7..00 for 1 newsletter subscription. This includes sales from A.A. material and non-A,A, material (medallions-etc.). Our total income for January was \$14,119.69. Our Total Cost of Goods Sold was \$2,517.82. Subtracting the Total Cost of Goods Sold from our January income left us with a Gross \$11,601.87. Our Total Expenses January were \$10,195.50. Subtracting our Expenses from our Gross Profit gave us a Net Income of plus+\$1,406.37 for the month of January. Last year was pretty ruff for us as far as contributions and literature sales. We netted about \$32,000.00 less from the previous year in contributions, about \$25,000.00 less in literature sales and couple that with rising expenses—electric, phone, rent, computer expenses—etc, it looked kind of bad. However, that is in the past and no need to dwell on it. We just need to keep moving forward. Currently, we still have a good Prudent Reserve, all our bills keep getting paid, the lights are on, we have a decent amount of literature available, the phones are working Thank you for your support. Let's come alive in 25!!! Thank You!!!O.M. tws:)

Tim replied that you can only pick up for your group. Some discussion followed and it was finally clarified that what she was wanting to do is pick up literature for another group that was also attending the Board & Council meeting but might have a hard time getting to the Office. Tim noted that this was acceptable. A motion to approve was made, it was then seconded and approved. Old Business: Central Office Anniversary: Scott B. noted that they had had a recent committee meeting and all service positions were accounted for, will be reaching out to the groups concerning napkins, plates, etc, Nes will be doing the catering for the event, ticket update was that 94 tickets were still available. He asked if everyone had flyers at their groups, and that still needed more cakes for the CakeWalk, they will be going with a panel for the speakers portion of the event with Michael P., John T. and Tom F., (some gargling occurred while Scott was trying to speak and Brad reminded everyone to mute themselves to eliminate the background noise) Another meeting will be this week and after this event we will have a Founders Day flyer. Nes stated that as far as desserts, he will be bring cheesecakes from New York and asked if they had gotten the plasticware. Sophie replied not yet. Okay we'll talk about that later. Brian noted that when we do the Founders Day, that's free, we don't charge anyone for that. Scott replied: Okay, we'll come up with flyers for that when we get close to it. Sophie said that Brian, it sounds like you have some experience with that and we would like to have you on the committee. She then Go to where the EVENTS page.......

went on to say that the venue is not free, the venue is \$800.00 generally speaking on the low end, we searched far and wide and ended up at the Palma Ceia Church, we interview several venues and none of them were free, we do try to offset the cost by charging folks a nominal price and providing them food but with our ticket sales up and still needing 91 tickets, not like we're coming out ahead, we're barely making the venue and the food cost, it depends on what kind of Founders Day we want to have, pleas join us on the ad hoc committee. Some more discussion followed. Tim will look into it. New Business: Nancy from the Hide-a-Way Group noted that they were a pretty traditional group but recently some people were picking up chips but saying it was from being clean from drugs not alcohol and some people discussing their issues with drugs even though we have reminded them that our topics are supposed to be about alcohol. They were not able to come to a decision at their group so she had said she would ask about it here at the Central Office meeting, how other groups handle this. Sophie noted that her home group The Old School Group that we do want to encourage that our rooms are open to everyone but with our singleness of purpose it limits are conversations to alcohol, our format change is that everyone is welcome but if you are not an alcoholic, you are welcome to observe. Each group is autonomous on how they want to handle this. Linda from the Tha's What I Wanted Women's Group noted they that's exactly how her group is. We don't encourage talking about drugs, sometimes someone will say that they are an alcoholic and a drug addict, we don't make a big deal out of that, we just don't want someone just saying that they are addicted to cocaine, we really prefer that they don't do that, we have a statement read at the beginning of the meeting saying we are alcoholics and want to discuss how their life is pertaining to alcohol. Nes came back with a question, that they only had four people sign up to help with the food, as far as serving food my past experience we will need more volunteers to help, as well with the drinks and coffee. Scott noted that that shouldn't be a problem. Debbi made a comment about the ticket sales, she had purchased a table of eight and then asked who in her group would like to come, if anyone at this meeting would like to do that with their group it can help with sales. This is a pretty important event the 50th Anniversary. Al shared his experience from an old timer who is no longer with us, that to let these people come into our meetings because what is going to happen is that they ain't going to stay long because they are not getting what they need. Scott brought up the reimbursement for the Quarterly and was informed that Area would handle that. He then bought up the idea of getting a printer for the office to print schedules in house. Al noted that we had talked about this before, to get a printing machine would cost a lot of money, Al asked Tim to comment. Tim asked who was going to do the printing? Me? Even with renting a large printer to do that, with the ink, paper-etc, all of that would be more than what we are paying our printing company to do. 2000 schedules is a little over \$600.00. Are you going to form a committee to do that? Brad noted that although it looks like you might be saving money, you're really not. Sending it off as been the best way that I know of since I've been coming here. Sophie noted that she was at the Area Assembly and that some, not all, of the districts were getting some kind of rented printer and maintenance contract, we would like to present that information from those districts for your consideration to the members here and the Board, it did seem pretty cheap and they run them on demand pretty much, she went on to talk about the printing of the When and Where's and the recent office hour time changes, therefore the When & Where's would not be correct. **Announcements**: Brad announced that the Tampa Bay Fall Roundup web site is live and that with the contract they had to sign with the hotel, they had to pay for the event ahead of time, so if you could go ahead and register, it would help with the cost of having the event. A question was asked about where the event was. It's all on the web site. Sophie announced a workshop February 15th at Old School

Group, she announced something about The Farm..Full Moon Fall In Love February 16th, a women's recovery event. Sophie wanted to know who would be interested in doing a Central Office orientation for anyone new or old who wants to know more about Central Office. It would be a zoom style meeting, about 30 minutes. Someone asked Tim about an update on the debit/credit card. Tim noted that he has a meeting with PNC next week. A motion to close was made, seconded and approved. Meeting ended with the Lord's Prayer.
